UK Dairy Trade Balance

- Exports for all dairy products rose between 2008 and 2009, with the exception of raw milk and milk powders.
- The imports in the raw milk market rose by 34 million litres between 2008 and 2009. While butter imports rose by 9,000 tonnes and cheese imports rose 6,000 tonnes.
- Comparing 2009 to 1999 shows that imports of raw milk and butter have fallen 25.2% and 20.4% respectively.


UK Trade Balance in spend terms

The provisional deficit in the UK trade balance in dairy products rose in 2008 by nearly £320m to nearly £1.2bn. The value of imported dairy products rose by nearly £380m while the value of dairy exports grew by only £62m.
