Vacancy Description

The Department for Environment, Food and Rural Affairs (Defra) is seeking applications for a new advisory group, the Bovine Tuberculosis (bTB) Partnership. The group will be a driving force for further progress with Defra's bTB strategy, which aims to secure Officially bTB Free status for England by 2038.

- Able to communicate confidently and effectively with a variety of people, balancing conflicting interests and negotiating/persuading to achieve consensus.
